



## **Disclosure according to Art. 4 Para. 4 of the Regulation (EC) No. 2273/2003 QIAGEN N.V. Share Repurchase – Interim Reporting**

On July 29, 2014, QIAGEN N.V. disclosed pursuant to art. 4 para. 2 of the Regulation (EC) no. 2273/2003 the beginning of a first tranche of the share buyback program on August 4, 2014.

The total number of shares which have been bought back on the electronic trading platform of the Frankfurt Stock Exchange (XETRA) within the framework of such tranche of the share repurchase program in the time period from August 4, 2014 until and including August 29, 2014 amounts to 260,200 shares.

The purchase of the shares of QIAGEN N.V. is carried out by a financial institution that has been commissioned by QIAGEN N.V..
